TERMS AND CONDITIONS:

This document details is the agreement between IndoMach Business Solutions (Organiser) and the Company (Exhibitor) participating in the Exhibition.

1. Stalls / Booths space allocation will be made on first come first serve basis.
2. This event will be a **B2B** Show. The Retail & Cash sale are not allowed during the exhibition, however negotiations may be conducted. Removal of any exhibit is prohibited during the exhibition period.
3. Use of public address systems audio-visual systems and height of display in the space booked in subject to no inconvenience to other participants and the organiser's decision in this regards shall be final.
4. Prefabricated Stall Height is 2.5 Mts (Approx 8Ft.) for raw space (Fabricated Stall). Exhibitor has to maintain the 2.5 Mts height, using the extra height is permissible only the approval from organising team.
5. The organiser will appoint general security for the exhibition period and No person will be allowed to stay after exhibition hours. Organiser shall not be responsible to any kind of losses / theft / damages to the exhibitor's property at the exhibition ground or Injury to their Personnel and Visitors.
6. Organiser reserves its right to changes the floor plan and the location of the Exhibitor(s) Space / Stall. If possible Exhibitor(s) will be stationed as per their original booking or equivalent thereof.

7. INSURANCE:

All the Exhibitors shall make sure that they are fully covered by insurance including risk on their Property or Article of any kind, Public Liability and comprehensive protection against any Loss / Damage / Theft caused by any circumstance.

8. PAYMENTS TERMS:

- a) 50% payment should be through current dated Cheque / Demand Draft along with the booking form to secure the booking of space. Balance 50% payment should be paid before 15 days to start of each exhibition.
- b) All payment should be made by Cheque / Demand draft / Online mode of payment (NEFT/ RTGS/ IMPS) in favour of **INDOMACH BUSINESS SOLUTIONS**.
- d) In case of exhibitor fail to make the payment on schedule or given dates, Organiser reserves the right to cancel the Participation.
- e) Stall / Booth space allocation will be made strictly upon full payment of Stall / Booth Fee / Charge received.

9. FORCE MEJEURE

If the Exhibition is Postponed / Cancel in whole or in part by reason of War, Fire, National Calamity, National Emergency, Election, Riots, National Pandemic, Strike, Non availability of Exhibition Ground / Hall, Government directives or due to any cause whatever beyond the control of the organiser, The organiser reserves the rights to change the Opening Date, Duration, Venue or even to Cancellation of entire Exhibition. In such condition the organiser is not responsible for any kind of losses sustained to the exhibitors directly or indirectly. The organiser may at their entire discretion to repay the rental paid by exhibitors.

10. CANCELTION OF BOOKING

If any Exhibitor cancel their booking before 30 days to start the show forfeit 50 % of the total stall charge + GST. If the cancelation is made within 30 days to start the show, Exhibitors have to pay 100% of total stall charge + GST.

11. Date of Exhibition, Venue, and Floor Plan may be change or postponed without any notice.

12. Jurisdiction of any dispute between Organiser and Exhibitors or conflict between any Party & Organiser will be in the court of Nagpur, India only.
